1. BACKGROUND OF THE ACTIVITY

Since April 2021, WES has been providing technical assistance to the Ministry of Environment (MoENV) of Jordan to support the implementation of the Green and circular Economy agenda and green investment opportunities in the waste sector in Jordan with emphasis on Single-Use Plastics and in advancing sustainable consumption and production. More specifically, with the support and services of WES consortium members MedWaves, ACR+, GOPA Infra, MIO-ECSDE and LDK Consultants, the WES national "twin" activities are nearing their conclusion:

- a) Activity N-E-JO-1, that contributes to the reduction of the use of Single-Use Plastics (SUPs) in Jordan, as advised in the Green Growth-National Action Plan on Waste under "Waste Sector Priority N°12
 Develop a joint public-private roadmap to transition to reduce the use of SUPs at the household and commercial levels".
- b) Activity N-E-JO-2, that tackles the aspects of green banking in relation to the same issue of the reduction of the use of SUPs.

Each activity included a consultation meeting in its work plan and it was decided to combine efforts and minimize participants' fatigue and organize a joint consultation meeting in May 2023.

2. OBJECTIVES OF THE CONSULTATION

The objective of the consultation workshop was to present and discuss with the relevant stakeholders, the outcomes of the two interlinked WES national activities on plastic waste management in Jordan:

- a draft Roadmap to address SUP items in Jordan that was prepared under the activity N-E-JO-1, Task 4;
- draft recommendations for stakeholders on green banking and green investment opportunities to curb plastic waste in Jordan that was prepared under the activity N-E-JO-2, Task 4.

3. OVERVIEW OF THE CONSULTATION

The consultation workshop, co-organised by WES with the Ministry of Environment of Jordan, was held on the 17th of May in Amman, Jordan, in the physical presence of the WES Team Leader and the WES international and local experts.

The workshop started with opening remarks by H.E Dr. Mohammad ALKHASHASHNEH - Secretary General, Ministry of Environment and WES Focal Point - Jordan and Mr. Omar Abu Eid – EU Delegation to the Hashemite Kingdom of Jordan, Energy, Environment & Climate Change Programme Manager Cooperation Section - Jordan.





Prof. Michael Scoullos - WES Team Leader, addressed the audience on how promoting green and circular economy can help in tackling plastic waste in Jordan.

He was followed by an overview of the Green Growth National Action Plan and the National Municipal Solid Waste Management Strategy presented by Dr. Jihad Alsawair, Director of Green Economy Unit and Minister Advisor for technical affairs at the Ministry of Environment.

Mr. Eyad Batarseh then presented the current situation in Jordan and proposed sustainable alternative options to transition away from manufacturing and using SUPs. This was followed by an initial round of discussions. The subsequent session focused on the presentation and discussion of the draft joint Roadmap to address SUPs in Jordan. Mr. Pedro Fernandez began by providing an overview of the regional context and proposed policy measures relating to single-use plastics. Ms Françoise Bonnet then presented the proposed public-private Roadmap to address SUP items in Jordan. These presentations were followed by an open discussion on the Jordanian specificities, obstacles and opportunities.

The afternoon session was dedicated to discussing green banking and green investment opportunities aimed at tackling plastic waste in Jordan. Mr. Mohamed Amaireh, the Executive Director of the Financial Stability Department at the Central Bank of Jordan, provided an update on the National Green Banking Strategy currently being developed in Jordan. Additionally, the WES team of experts, consisting of Dr. Adli Kandah, Dr. Koussai Quteishat, and Eng. Ahmad Al Qatarneh, presented the draft recommendations for stakeholders regarding green banking and green investment opportunities to curb plastic waste in Jordan. The discussions continued throughout this session.

4. **PROFILE OF THE PARTICIPANTS**

Invitees to the consultation were the major stakeholders linked to SUPs and plastics in the country: representatives of relevant ministries, agencies and local authorities, the private sector ranging from solid waste operators, the plastics industry to the banking sector, numerous associations, research institutions, donors, NGOs, etc.

At least 36 participants attended the consultation. The graphs below indicate the distribution among institutions as well as the gender and age of the participants (see list of participants in annex).









FIGURE 4-1: REPRESENTATION OF PARTICIPANTS PER TYPE OF INSTITUTION

4.1. STATISTICS GENDER AND YOUTH

This event achieved a perfect gender balance (50% of participants were women and 50% were men), while 3% of the participants were below or equal to 30 years old (or between the age group 18-30). For this specific theme (SUPs) it would have been nice to have more youth benefitting from the experiences and discussions and more participants from the private sector - mainly manufacturers.












FIGURE 4-3: PARTICIPANTS' AGE




A. Organisational, administrative and planning issues before and during the event








FIGURE 5-3: EVALUATION OF PRESENTATIONS (A.4)




FIGURE 5-5: EFFICIENCY AND EFFECTIVENESS OF THE FACILITATION (A.6)





FIGURE 5-6: CONSULTATION WORKSHOP COVERAGE (B.1)

FIGURE 5-7: EFFICIENT AND EFFECTIVE PERFORMANCE AND INTERACTION WITH EXPERTS (B.2)










FIGURE 5-8: CONSULTATION WORKSHOP LENGTH (B.3)

6. **CONCLUSIONS & OVERALL ASSESSMENT**

The conclusions of the consultation session included the following:

- 1) All participants agreed on the importance of further and in-depth information on the topic of SUPs and the importance of having a road map for its reduction and elimination.
- 2) Overall, there was a general agreement on the measures and timeline proposed for implementing the roadmap on SUPs. Only minor comments were brought up (nothing major).
- 3) A number of interventions stressed the need for focusing on implementation and enforcement, since several planning reports have been produced over the last years but final impact is still low.
- 4) The impacts of measures on different aspects of SUPs were also discussed. An important part of the management is related to collection and separation. When it comes to the informal sector, there is a need for the issue to be properly addressed and taken into account within any enhancement of the collection systems in the country.
- 5) Education was acknowledged as a major tool to drive sustainable consumption in Jordan.
- 6) It was pointed out that public procurement offers an opportunity for administration to show commitment, coherence and lead the transition to reusable options.
- 7) For implementing the road map, there were two views expressed within the session: (a) one view was for gradual soft implementation, where a good period is spent on awareness, education and labeling campaigns with voluntary participation; (b) the second view was for introducing enforcements early on, in order to demonstrate visible results and successes in the short term. Both of the views had good merits and justifications. Finally, it was agreed to take this decision after starting the road map implementation as per the reaction of the different sectors to the road map and as per the progress with other supporting tools such as the EPR system.
- 8) Regarding green banking and green investment opportunities to curb plastic waste in Jordan, the four presentations (one from the CBJ representative and three from the NKE experts of the twin activity) shed light on the following:
 - a. The CBJ current status in the development of a National Strategy towards Green Banking, which is a positive development. This is in anticipation that such a strategy capitalizes on situation of existing experience (notably renewable energy), elaborating a financial vehicle for plastics/SUPs and developing a centralized database.
 - b. Basic results of the survey conducted for 14 banks in Jordan and their response showing some maturity in applying green banking to renewable energy practice, while nearly nil in solid waste in general, and plastics with concentration on SUPs, in particular.





- c. Reforms needed within the various relevant institutions for enhancing the enabling conditions for green banking and green investment to curb plastic waste and address SUPs, particularly within the Ministry of Environment and inclusive of the Ministry of Local Administration, Ministry of Investment, Ministry of Industry and Trade and Supply, Central Bank of Jordan (CBJ), Association of Banks of Jordan (ABJ), and the Chamber of Industry (CI).
- d. The good and profitable business opportunities offered by many projects related to plastics recycling.
- e. The need for suitable communication and education to stimulate necessary behavioral changes from the public, and raising funding awareness.
- f. Suggestions on capacity building needs to enhance ownership and management of such serious matters in the fight against plastics in general, but confined first to the need for drastic reduction and phasing out of SUPs.
- g. The case of the Jordan Kuwait Bank, which has issued the first Green Bond, valued at JOD 50 million, and has shown keen interest in green projects and is fully welcoming WES involvement /support.
